Meta

Mis/Disinformation

Meta, which owns Facebook, Instagram, and WhatsApp, says its election-related policies focus on "preventing interference, fighting misinformation, and increasing transparency." Prohibited content includes:

- 1. Posts containing false or misleading information about election dates, locations, times, or eligibility;
- 2. Posts that feature false or misleading information about the methods of voting or whether a vote will be counted;
- 3. Misleading posts about whether a candidate is running; and
- 4. Coordinated calls for voter/elections interference.

Prohibited content may be removed, designated for "reduced" distribution into users' newsfeeds, or labeled with additional information. While third-party fact-checkers previously applied these labels, Meta <u>announced</u> in January 2025 that it will phase out its third-party fact-checking program in the US and transition to a Community Notes model. Under this approach, independent contributors—not professional fact-checkers—will provide context on potentially misleading content. Meta <u>policies</u> on misinformation indicate that content that poses an immediate risk of physical harm or electoral interference is likely to be removed altogether, whereas content containing general misinformation and disinformation will be subject to labels from Community Notes contributors when applicable. Posts that violate Meta policies may sometimes remain accessible if the company determines "the public interest outweighs the risk of harm," though Meta states that posts promoting violence or suppressing voting are not considered for this exemption.

As of February 2025, Meta has not provided a specific timeline for when it will transition from third-party fact checkers to community notes. The company has also not specified the process or criteria for users to be accredited to rate or write notes.

Exemptions for Politicians

In its January 2025 policy updates, Meta did not state whether politicians are exempt from the Community Notes program, as they <u>were</u> from its previous third-party fact-checking program. Therefore, it is reasonable to infer that posts and ads by politicians are subject to the same Community Notes process as other content.

Meta policies prohibit politicians from posting misinformation on where, when, or how to vote and content inciting violence. Other previous policies allowing for the addition of labels and third-party fact-checking for premature claims of victory, are also subject to change under the January 2025 updates. As Meta transitions away from third-party fact-checking, the application of labels and enforcement mechanisms may evolve.



Ad Requirements

Advertisers seeking to publish ads on Meta platforms that address "social issues, elections or politics" must be <u>authorized</u> before doing so. Such ads on Facebook and <u>Instagram</u> must have a "Paid for by" disclaimer. Meta's <u>ad library</u> makes available information about current and past ads, including their received audiences and how much money was spent promoting them.

Ads about social issues, elections, or politics are subject to more stringent content moderation <u>policies</u>. For example, Meta <u>prohibits</u> and removes ads that discourage voting, prematurely claim victory, attempt to delegitimize an upcoming election, or are inconsistent with health authorities on voting safely. Meta does not ban ads that claim a prior election was illegitimate or rigged, however.

Meta <u>requires</u> advertisers to disclose AI-generated or digitally altered content in ads related to politics, elections, or social issues. For example, any photorealistic AI images, videos, and audio depicting real people or events must be disclosed.

Meta will <u>block</u> new ads about social issues, elections, or politics during the final week of the US election campaign. Ads previously run before the restriction will be allowed to continue during this time. This restriction lifts the day after the elections.

Threats/Harassment

Ads or posts that incite violence are not permitted, from any type of user — e.g., individual, politician, organization, or any other. Related to elections, Meta explicitly forbids:

- 1. Threats targeting election officials or are related "to voting, voter registration, or the outcome of an election"; and
- 2. Calls to bring weapons to election-related locations.

Doxing

Meta forbids content that "shares, offers or solicits personally identifiable information or other private information that could lead to physical or financial harm, including financial, residential, and medical information, as well as private information obtained from illegal sources" such as hacking.

Meta <u>implemented</u> a recommendation by its Oversight Board which removed its "publicly available" exception for private residential information from both Facebook and Instagram, however its policies related to sharing photos of the exteriors of private homes have exceptions for when the property "is the focus of the news story, except when shared in the context of organizing protests against the resident."

WhatsApp does not have a user-based doxing policy.



Political Content

In January 2025, Meta announced the removal of its policies limiting political content recommendations on Facebook, Instagram, and Threads, in favor of a more "personalized approach." Under this new approach, civic content will present like any other content in a user's feed, with the algorithm ranking it based on user engagement. Meta also announced it would start recommending more political content based on personalized signals, while expanding the options users have to control how much political content they see in their feed.

Facebook–Specific Policies

Facebook "demotes" Group content from members who violate Community Guidelines on the platform. This includes restricting their ability to like comment, add new members to a Group or create a new Group.

Instagram-Specific Policies

Instagram's <u>policy</u> states it removes "misinformation that could cause physical harm or suppress voting." However, merely false or misleading content, "including claims that have been found false by independent fact-checkers or certain expert organizations," is allowed on the platform, though it is not included in algorithm-driven "recommended" content that appears to users via the platform's "Explore" feed, "Accounts You May Like" suggestions, or the "Reels" tab.

Manipulated Media

Meta <u>removes</u> misleading manipulated media if it "has been edited or synthesized [...] in ways that aren't apparent to an average person and would likely mislead someone into thinking that a subject of the video said words that they did not actually say" and if the media is a product of AI or machine learning that "merges, replaces or superimposes content onto a video, making it appear to be authentic." This policy does not apply to content that is parody or satire or a video that has been edited to omit or "change the order of words." If a post containing misleading manipulated media does not meet the standards for removal, they are still eligible for review by Meta's third-party fact-checkers.

In response to a recommendation from its Oversight Board, Meta <u>announced</u> in April 2024 that it would extend its manipulated media policy to include labelling synthetically generated content that makes it appear as though someone did something they did not do. This closes a loophole in the previous policy, which only covered manipulated speech.

Meta has <u>dodged questions</u> about whether politicians can post AI-generated media or manipulated media without warnings or removals. At the time of writing, it would seem Meta will only fact-check manipulated media posted by politicians, rather than applying their larger manipulated media policy to such content.



YouTube

Mis/Disinformation

YouTube has a specific elections misinformation **policy** that states content that suppresses or prevents voting, undermines election integrity, and otherwise spreads election misinformation is in violation of the platform's community standards and may be removed. The platform's Terms of Service defines election misinformation-related content as "misleading or deceptive," with "serious risk of egregious harm ... [including] technically manipulated content and content interfering with democratic processes." Clips taken out of context or deceptively edited <u>do not</u> fall under the definition of "manipulated content."

The **policy** elaborates on specific forms of elections misinformation, including but not limited to:

- Content that promotes voter suppression or is misleading regarding whether specific candidates are eligible and running;
- Content that encourages individuals to "interfere with democratic processes" which may include "obstructing or interrupting voting procedures";
- Distributing information obtained through hacking, "the disclosure of which may interfere with democratic processes"; and
- Content that undermines the integrity of elections, including claims that fraud or errors are widespread "in certain past certified national elections." As of August 2023, this currently applies to the 2021 German federal election and 2014, 2018, and 2022 Brazilian Presidential elections. The US 2020 federal election has been removed from the list. YouTube <u>stated</u> that "while removing [content with misleading claims about the 2020 election] does curb some misinformation, it could also have the unintended effect of curtailing political speech without meaningfully reducing the risk of violence or other real-world harm."

YouTube's election misinformation policy also covers external links shared in content posted on YouTube, including URLs and verbal directions to another site. The policy also does not allow users to post previously removed content or share content from terminated or restricted users. If a user's content violates this policy, YouTube states it removes the content and sends an email to the user. On the first violation, the account receives a warning; however, it will receive a strike following each subsequent incident. After three strikes, the channel is terminated.

Ad Requirements

<u>Political ads</u> on YouTube must adhere to Google's <u>ad policies</u>, which requires political organizations to go through <u>verification</u> before running ads on Google platforms. Ads on YouTube are also subject to the <u>community guidelines</u> on election misinformation. Monetized channels are subject to eligibility <u>requirements</u>.

Threats/Harassment

YouTube has a <u>Harmful or Dangerous Content Policy</u>, <u>Hate Speech Policy</u>, and <u>Harassment</u> <u>and Cyberbullying Policy</u>. Though not specific to elections, YouTube prohibits:

• Inciting others to commit violent acts against individuals or a defined group of people;



- Promoting violence or hatred against individuals or groups based on age, caste, disability, ethnicity, gender identify and expression, nationality, race, immigration status, religion, sex/gender, sexual orientation, victims of a major violent event and their kin, or veteran status;
- Content that threatens individuals;
- Content that targets an individual with prolonged or malicious insults based on intrinsic attributes, including protected group status or physical traits.

YouTube does have exceptions for harassment, if "the primary purpose is educational, documentary, scientific, or artistic in nature, we may allow content that includes harassment." For example, "Content featuring debates or discussions of topical issues concerning individuals who have positions of power, like high-profile government officials or CEOs of major multinational corporations."

Doxing

YouTube's <u>Harassment and Cyberbullying Policies</u> state that users are not allowed to post content that reveals someone's personally identifiable information (PII). Additionally, YouTube explicitly states that abusive behavior, such as doxing, is banned from the site. Exceptions to this include posting widely available information such as the phone number of a business.

Manipulated Media

YouTube's policies regarding manipulated content fall under the platform's <u>Misinformation</u> <u>Policy</u>. The platform defines manipulated content as "content that has been technically manipulated or doctored in a way that misleads users (beyond clips taken out of context) and may pose a serious risk of egregious harm." Some examples that YouTube provides include:

- 1. Inaccurately translated video subtitles that inflame geopolitical tensions creating serious risk of egregious harm.
- 2. Videos that have been technically manipulated (beyond clips taken out of context) to make it appear that a government official is dead.
- 3. Video content that has been technically manipulated (beyond clips taken out of context) to fabricate events where there's a serious risk of egregious harm.

TikTok

Mis/Disinformation

TikTok's <u>Election Integrity</u> policies do not allow for content that spreads distrust in public institutions, claims votes will not be counted, misrepresents election dates or locations, or attempts to suppress votes. Unverified claims, such as early declarations of victory or unconfirmed stories about polling locations, are <u>made</u> ineligible for recommendation to viewers. Accounts that are entirely dedicated to spreading election related mis- or disinformation are <u>banned</u>.

In 2022, TikTok launched an "Election Center" to connect users who engage with electionrelated content to "authoritative information and sources in more than 45 languages." The information includes how and where to vote, who and what is on the ballot. As elections were



conducted in the US, TikTok displayed results from the Associated Press. The company also worked with fact-checking groups like PolitiFact.

There are a variety of policy enforcement mechanisms TikTok uses, including:

- Removing content;
- Redirecting search results;
- Restricting discoverability, for example, by making content ineligible for the "For You" page;
- Blocking accounts from livestreaming;
- Removing an account; and
- Banning a device from the platform, in the case of serious violations of community guidelines.

Manipulated Media

In April 2023, TikTok <u>updated</u> its <u>Integrity and Authenticity Policy</u> to include synthetic and manipulated media. The Synthetic and Manipulated Media Policy states that "synthetic or manipulated media that shows realistic scenes must be clearly disclosed" and that the platform does not allow synthetic media that "contains the likeness of any real private figures." The platform is more lax for public figures but does not allow "synthetic media of public figures if the content is used for endorsements or violates any other policy" (e.g., hate speech, harassment, sexual exploitation).

TikTok's definition of synthetic media is "content created or modified by AI technology that includes highly realistic digitally created content of real people, such as a video of a real person speaking words that have been modified or changed." The platform's definition of public figures is "adults (18 years and older) with a significant public role, such as a government official, politician, business leader, and celebrity."

Ad Requirements

TikTok does not allow paid political ads and has vowed to work to tighten an existing <u>loophole</u> in its policies that some content creators used to receive payment in exchange for posting political messages online.

Threats/Harassment

TikTok's **Election Integrity** policy does not allow:

- "Newsworthy content that incites people to violence";
- Livestreams that seek to "incite violence or promote hateful ideologies, conspiracies, or disinformation"; and
- Redirect search results or hashtags that incite violence or are associated with hate speech.

In addition to its election focused policy, TikTok's Community Guidelines prohibit users from using TikTok "to threaten or incite violence, or to promote violent extremist organizations, individuals, or acts."



Regarding harassment, TikTok does not allow:

- Content that insults another individual, or disparages an individual based on attributes such as intellect, appearance, personality traits, or hygiene
- Content that encourages coordinated harassment
- Content that disparages victims of violent tragedies
- Content that uses TikTok interactive features (e.g., duet) to degrade others
- Content that depicts willful harm or intimidation, such as cyberstalking or trolling
- Content that wishes death, serious disease, or other serious harm on an individual.

Doxing

TikTok's <u>Community Guidelines</u> state the company forbids threats of hacking or doxing users with the intention to harass or blackmail users that can cause "serious emotional distress and other offline harm." TikTok prohibits "content that includes personal information that may create a risk of stalking, violence, phishing, fraud, identity theft, or financial exploitation," including content posted by a user about themselves.

Snapchat

Mis/Disinformation

Snap <u>prohibits</u> spreading false information including "denying the existence of tragic events, unsubstantiated medical claims, undermining the integrity of civic processes, or manipulating content for false or misleading purposes." Snap's policies on election mis- and disinformation include bans on content that includes false information about election procedures, intimidation or rumors aimed at deterring participation, encouraging unlawful participation, and false claims meant to delegitimize elections.

Snap <u>pre-moderates</u> content on its Spotlight and Discover pages before it goes to a large audience, and limits the distribution of news and political content unless it is posted by trusted publishers or creators.

Manipulated Media

Snap prohibits "manipulating content for false or misleading purposes" including to interfere with elections or impersonate a public official. This policy applies to AI-generated content as well as selective editing.

Ad Requirements

Snap applies the same <u>Community Guidelines</u> to political ads as to user-generated content. Political ads are subject to fact-checking and must include a 'paid for by' disclosure.

Threats/Harassment

Snap <u>prohibits</u> threats and harassment, including against public figures. This includes "expressing support for violence, or encouraging violence against anyone." Snap's antibullying policy bans "attempts to embarrass or humiliate someone, wishing harm upon someone, sexual harassment, and invasions of privacy."



Doxing

Snap's anti-harassment policy includes a prohibition on sharing someone's private information "without their knowledge and consent or for the purpose of harassment."

Telegram

Mis/Disinformation

<u>Telegram</u> does not have a stated policy related to elections or to mis- or disinformation.

Ad Requirements

Telegram does not have a stated policy on political ads.

Threats/Harassment

Telegram's <u>Terms of Service</u> prohibits calls to violence. The platform does engage in periodic moderation of hateful and violent channels—<u>including</u> in the aftermath of the Jan 6 Capitol attack—however, moderation is applied irregularly and inconsistently.

Doxing

Telegram does not have a user-based doxing policy.

Manipulated Media

Telegram does not have a Manipulated Media policy.

X (formerly Twitter)

Mis/Disinformation

X's <u>Civic Integrity Policy</u> prohibits "manipulating or interfering in elections or other civic processes." The company's definition of civic processes includes political elections, censuses, and referenda or ballot initiatives. Violations of this policy include:

- Content that suppresses participation, dissuades, or misleads users about how to participate in civic processes;
- Content that misleads people about the outcome of an election, or undermines trust in electoral processes; and
- Accounts that pretend to be a political candidate, political party, electoral authority, or government entity – unless the accounts are parody, commentary, or fan accounts. Accounts that fall under this latter category must distinguish themselves in their account name and bio, according to the <u>Misleading and Deceptive Identities Policy</u>.

X addresses violations of this policy through:

- Post deletion;
- Requiring the user to remove the content;
- Temporarily locking the user out of their account;
- Profile modifications, if the violating content is within the profile information;
- Labeling Posts to warn they are misleading, or providing links with additional context;



- Turning off the ability to Repost, like, or reply to a Post;
- And locking or suspending the account.

On April 1, 2023, X removed blue checkmark badges from verified accounts that were not signed up for paid X Blue subscriptions. Several politicians lost their verification and Musk's new system gave way for a new spread of fake accounts. Musk then implemented grey checkmarks for government/multilateral organizations and officials. The <u>features</u> that were put in place for 2022 midterms (including "<u>prebunks</u>" and state-specific event hubs) no longer exist, and it is unclear if they will be brought back before 2024 elections.

Additionally, Musk introduced <u>Community Notes</u>, which allows X users to add context to potentially misleading Posts (formerly Tweets).

Ad Requirements

In 2023, X <u>lifted</u> the long-time ban on paid ads featuring political content that references political candidates, parties, elections, or legislation in the US. Political campaigning ads can now be promoted through the following <u>ad formats</u>: Promoted Ads, Follower Ads, X Takeover, X Live, DPA, Collection Ads, and X Ad Features. However, political content cannot include:

- False or misleading information about how to participate in an election;
- False or misleading information intended to intimidate or dissuade people from participating in an election;
- False or misleading information intended to undermine public confidence in an election.

Additionally, X states that "advertisers must comply with any applicable laws regarding disclosure and content requirements. Such compliance is the sole responsibility of the advertiser." Political ads on X are subject to fact-checking and contextualization through Community Notes.

X also created a <u>Political Ads Disclosure page</u> to allow anyone to request information on US Political Campaigning ads via <u>Google Form</u>.

Threats/Harassment

X has a <u>Violent Speech Policy</u> that prohibits threats, incitement, glorification, or expressions of desire for violence or harm. Violations of this policy include, but are not limited to:

- Threatening to kill someone;
- Threatening to sexually assault someone;
- Threatening to damage civilian homes, infrastructure, and shelters;
- Wishing, hoping, or expressing desire for harm;
- Inciting, promoting, or encouraging others to commit acts of violence or harm;
- Glorifying, praising, or celebrating acts of violence where harm occurred.

X does not ban all violent rhetoric or threatening content. According to the company, expressions of violent speech when "there is no clear abusive or violent context" or is a "figure of speech, satire, or artistic expression" are not violations.



X also has a <u>Hateful Conduct Policy</u> and <u>Abuse and Harassment Policy</u>. According to the Hateful Conduct Policy, users "may not promote violence against or directly attack or threaten other people on the basis of race, ethnicity, national origin, caste, sexual orientation, gender, gender identity, religious affiliation, age, disability, or serious disease." X also acts against "reports of accounts targeting an individual or group of people."

Doxing

X's <u>Private Information and Media Policy</u> prohibits users from publishing or posting another individual's private information without express permission. The company also forbids threats of exposing private information, encouraging others to do so, sharing information that could facilitate "access to someone's private information without their consent," and offering or soliciting bounties in exchange for posting or not posting private information. In March 2024, X extended this policy to ban exposing identities of anonymous users.

X claims that when a user violates this policy for the first time, the account is required to remove the content and will be temporarily locked. If the violation occurs a second time, the account will be permanently suspended. Accounts dedicated to sharing someone's "live location" are automatically suspended.

In December 2022, X updated its Private Information and Media Policy to prohibit users from sharing "live information" about an individual, or their "real-time and/or same-day information where there is potential that the individual could still be at the named location." This update came after X <u>banned</u> @elonjet, an account that used publicly available flight data to track Elon Musk's private jet.

Manipulated Media

X's Synthetic and Manipulated Media Policy prohibits "synthetic, manipulated, or out-ofcontext media that may deceive or confuse people and lead to harm ('misleading media')." The company defines misleading media as images, videos, audios, gifs, and URLs hosting relevant content that:

- Includes media that is significantly and deceptively altered, manipulated, or fabricated, or;
- Includes media that is shared in a deceptive manner or with false context, and;
- Includes media likely to result in widespread confusion on public issues, impact public safety, or cause serious harm.

When considering whether to label or remove content containing manipulated media, X considers three questions:

- 1. Is the content significantly and deceptively altered, manipulated, or fabricated?
- 2. Is the content shared in a deceptive manner or with false context?
- 3. Is the content likely to result in widespread confusion on public issues, impact public safety, or cause serious harm?

Manipulated media in the form of memes, satire, animations, illustrations, cartoons, commentary, and counter speech – minus some exceptions – do not violate this policy.



If content is found to violate X's Synthetic and Manipulated Media Policy, the platform can:

- Delete the post;
- Apply a label and/or warning message to the post;
- Reduce the visibility of the post on the platform;
- Provide a link to additional explanations or clarifications;
- Temporarily reduce the visibility of the account or lock or suspend the account.

Bluesky

Bluesky Social's <u>Community Guidelines</u> are designed to empower user choice, stating that the platform aims to "provide users with the ability to select self-governing services that align with their personal preferences and values."

Bluesky follows a <u>decentralized moderation</u> approach, primarily relying on an open labeling system rather than centralized enforcement. This system allows developers, organizations, and users to mark content that may need to be hidden, blurred, taken down, or annotated in the application. Although this system is largely decentralized, Bluesky sets some <u>rules</u> for labeling accounts, and violations of these rules can result in penalties, including the removal of labels, suspension of accounts, and defederation of labeling services.

Bluesky also employs an automated system to remove clearly fake, scam, or spam accounts. In addition, the Community Guidelines Bluesky may moderate content "at [its] discretion," meaning it retains the right to intervene directly in cases where it determines a violation has occurred. However, it is unclear what specific cases warrant direct intervention or how and when Bluesky decides to enforce such moderation.

Mis/Disinformation

Bluesky <u>prohibits</u> the dissemination of false or misleading content that could harm or disrupt public discourse. This includes:

- Posts that engage in voter suppression or share misleading content about election processes.
- Posts that encourage or glorify the intimidation of election participants or real-world disruption of the election processes.
- Misleading content falsely attributed to candidates in elections.

Moderation of misinformation occurs primarily through <u>labeling</u>, meaning enforcement largely depends on third-party moderation services and user reports rather than direct intervention by Bluesky itself.

Ad Requirements

As of 2025, Bluesky has not publicly detailed specific advertising policies, particularly concerning political content.



Threats/Harassment

Bluesky's Community guidelines strictly <u>prohibit</u> harassment or abuse directed at individuals or groups. This includes:

- Threats of violence, stalking, or any behavior intended to intimidate others.
- Coordinated harassment or dogpiling, including harmful quote-posting

The platform uses "<u>anti-toxicity</u>" features to mitigate harassment, allowing users to detach their posts from toxic quote posts to prevent dogpiling, hide replies, or subscribe to blocklists, among other features.

Users are encouraged to report any threatening or harassing content, which is subject to review and potential removal by the moderation team.

Doxing

Bluesky <u>prohibits</u> stealing or distributing others' private personal information without their permission. Doxing may result in content removal and account suspension.

Manipulated media

Bluesky has not publicly detailed a specific policy regarding manipulated media. However, its default moderation system applies <u>labels</u> to content related extremism, misinformation, fake accounts, and adult content. This labeling system does not clarify whether manipulated media falls under Bluesky's misinformation policies.

Reddit

Mis/Disinformation

Content moderation is handled at Reddit at a site-wide level, community level, and user level. Reddit's <u>content policy</u> does not specifically address elections. Communities are given deference to write and enforce their own rules, meaning that policies on election-related misinformation and disinformation can vary wildly. A Reddit spokesperson <u>told</u> Consumer Reports in 2020 that misinformation on voting was banned, but that it wasn't included in published policies.

Reddit enforces its policies through:

- Warnings to cease violating behavior;
- Account suspension;
- Restrictions added to Reddit communities, such as Not Safe for Work (NSFW) tags or <u>Quarantining;</u>
- Content deletion; and
- Community bans.

Ad Requirements

Reddit's ad <u>policy</u> bans "deceptive, untrue, or misleading" advertisements. In addition, <u>political</u> advertisers must allow users to comment on their ads for at least 24 hours after posting and include clear "paid for by" disclaimers, and candidates or official



representatives must participate in an "ask me anything" (AMA) prior to placing ads. Reddit forbids political ads from outside of the United States and only accepts ads for campaigns and issues at the federal level. Ads that discourage voting or registering to vote are <u>not allowed</u>.

In 2020, Reddit launched an official <u>subreddit</u> to list all political ads running on the platform. Posts in this subreddit included information such as the name of the organization, the amount they spent on an ad, and which subreddits were targeted with the ad.

Threats/Harassment

Reddit bans users and communities that "incite violence or that promote hate," and does not allow confidential information to be posted.

In February 2025, Reddit <u>issued</u> temporary bans on several communities due to an increase in rule-breaking posts, particularly those inciting violence against employees of the Elon Musk-led Department of Government Efficiency (DOGE). For example, the subreddit r/WhitePeopleTwitter received a 72-hour ban for violent content, and r/IsElonDeadYet was permanently banned for similar reasons.

Doxing

Reddit's Content Policy prohibits the "instigation of harassment," including revealing someone else's personal confidential information, including "links to public Facebook pages and screenshots of Facebook pages with the names still legible." Exceptions to the rule can include posting professional links of public figures, such as the CEO of a company, if the post does not encourage harassment or "obvious vigilantism." Users who violate these policies could be banned from the platform.

Manipulated Media

Reddit <u>bans content</u> that impersonates individuals or entities in a "misleading or deceptive manner." This includes "deepfakes or other manipulated content presented to mislead, or falsely attributed to an individual or entity."

Gab

Mis/Disinformation

Gab does not have a stated policy related to elections or to mis- or disinformation.

Ad Requirements

Gab does not have a stated policy on political ads.

Threats/Harassment

The platform's <u>Terms of Service</u> forbids illegal content and "unlawful threats." Additionally, Gab's policy states users "agree not to use" Gab to engage in conduct which, as determined by the company, "may result in the physical harm or offline harassment of the Company, individual users of the Website or any other person (e.g. 'doxing'), or expose them to liability."



Doxing

Gab's <u>Terms of Service</u> prohibits users from sharing information that could result in physical harm, offline harassment or expose them to liability (i.e. sharing personal information).

Manipulated Media

Gab does not have a stated policy on manipulated media.

Truth Social

Mis/Disinformation

Truth Social's <u>moderation</u> page states the company moderates the platform to prevent "illegal and other prohibited content," but that they "cherish free expression." While the <u>Terms of Service</u> do not contain any references to elections or misinformation, they state users "may not post any false, unlawful, threatening, defamatory, harassing or misleading statements" or post content that is "false, inaccurate, or misleading." It is unknown how "false," "inaccurate," or "misleading" are defined.

Ad Requirements

Truth Social does not have a stated political ads policy.

Threats/Harassment

Truth Social's <u>Terms of Service</u> prohibits threats and harassment on the platforms including posts or contributions that:

- Depict violence, threats of violence or criminal activity;
- Advocate or incite, encourage, or threaten physical harm against another;
- Are false, unlawful, threatening, defamatory, harassing or misleading statements;
- Use any information from the Truth Social in order to harass, abuse, or harm another person; and
- Are obscene, lewd, lascivious, filthy, violent, harassing, libelous, slanderous, or otherwise objectionable.

Doxing

Truth Social's Community Guidelines appear to allow for reporting content "sharing or threatening to share the private information of an individual without their consent or breach of privacy rights of others." The platform does not specify enforcement mechanisms.

Manipulated Media

Truth Social does not have a stated policy on manipulated media. It is worth to note that in late May 2023, Trump <u>posted</u> a fan-made fake video seemingly using AI-generated voices of Adolf Hitler, George Soros, WEF chairman Klaus Schwab, former VP Dick Cheney, and the FBI. The video was attacking Ron DeSantis' Twitter Spaces event with Elon Musk, where DeSantis was slated to announce his candidacy for 2024. This suggests there might not be strict policies on deepfakes or altered content.
